**AWARDING PROFESSIONAL SERVICE CONTRACT
FAIR AND OPEN
LEGAL SERVICES
SEIDEN WAYNE, LLC
(\$100,000.00)**

WHEREAS, the County issued a Request for Qualifications and sought a firm with expertise to investigate and evaluate allegations of sexual and workplace harassment and hostile work environment and discrimination against the County or County employees for the period of January 1, 2008 through December 31, 2008; and

WHEREAS, such services are to be acquired through a fair and open process pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the Purchasing Department advertised for Qualification Statements, distributed a Request for Qualifications to ten qualified firms, received six Qualification Statements and selected the firm of Seiden Wayne, LLC, Two Penn Plaza East, Newark, New Jersey 07105; and

WHEREAS, the maximum amount of this contract shall not exceed **ONE HUNDRED THOUSAND (\$100,000.00) DOLLARS**, with an attorney rate of **ONE HUNDRED FIFTY (\$150.00) DOLLARS** per hour, and funds are available for this purpose in Account No. 003B as certified by the Director of the Department of Finance and Administration; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., permits the awarding of a contract for professional services without public advertising for bids, and requires that the resolution and the terms be available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders to the County of Hudson, that:

1. The aforesaid recitals are incorporated herein as though fully set forth at length.
2. The Board hereby authorizes the County Executive, or his lawfully appointed designee, to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of this resolution.
3. The County Executive, or his lawful designee, is hereby authorized to pay for the above referenced services based upon the following information:




