

1 OFFICER OCASIO: -- like the whole --
2 everything that's going on now?

3 WITNESS #1: Yeah.

4 OFFICER OCASIO: But you always like -- I
5 talked to you a couple of times, and you said that
6 like, you've seen him do this shit.

7 WITNESS #1: Yeah.

8 OFFICER OCASIO: Like it never -- like,
9 how? Like, I need -- I would love to know how?

8 OFFICER OCASIO: He listens to me?

9 WITNESS #1: Hm-hm. And Murray.

10 OFFICER OCASIO: He listens to Murray.
11 Patty? Or he listens to us when we talk to Patty?

12 WITNESS #1: Probably listen to y'all
13 when y'all talk to Patty.

14 OFFICER OCASIO: Okay.

15 WITNESS #1: He might listen to y'all
16 when y'all talk to Patty because something happened
17 with her and I said, do you have her number? He
18 was like, she had all that on that website. So I
19 don't know if she do or not because you could check
20 my --(indiscernible)--

21 OFFICER OCASIO: Her number?

22 WITNESS #1: Yeah her number and stuff.
23 He said it was from that EPD whatever -- was --
24 (indiscernible)-- because I said to -- I said to --
25 (indiscernible)-- I said, you have her number. He

1 said, yeah I got that bitch number. But let me
